

**EMERGENCY ORDINANCE NO. 2015-20A**

AN ORDINANCE DIRECTING THE DIRECTOR OF FINANCE TO CERTIFY ANY AND ALL UNPAID ASSESSMENTS TO THE BUTLER COUNTY AUDITOR FOR MOWING OF PROPERTY IN VIOLATION OF CHAPTER 674 OF THE CODIFIED ORDINANCES AND DECLARING AN EMERGENCY.

WHEREAS, pursuant to Chapter 674 of the Codified Ordinances the City mows properties found in violation; and

WHEREAS, certain invoices remain unpaid.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF MONROE, STATE OF OHIO, THAT:

SECTION 1: The Director of Finance, pursuant to Section 236.03 of the Administrative Code, is hereby directed to certify any and all unpaid assessments to the County Auditor immediately upon passage of this Ordinance.

SECTION 2: The Director of Finance is hereby ordered to request the Butler County Auditor to place the amounts set forth on Exhibit "A", attached hereto and made a part hereof, on the tax list together with the additional 10% administrative cost, to be collected with and in the same manner as State and County taxes and credited to the City of Monroe.

SECTION 3: The Director of Finance is hereby ordered to inform the Butler County Auditor that more than 30 days have intervened from the date of notice of the unpaid amount owed.

SECTION 4: This measure is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare and further for the reason hat Council desires to certify the unpaid assessments at the earliest possible date and prior to the deadline of September 14, 2015. Therefore, this measure shall take effect and be in full force from and after its passage.
