

EMERGENCY RESOLUTION NO. 04-2016

A RESOLUTION EXPRESSING COUNCIL'S INTENT FOR THE SALE OF PERSONAL PROPERTY NOT NEEDED FOR PUBLIC USE OR IS OBSOLETE OR UNFIT FOR THE USE FOR WHICH IT WAS ACQUIRED BY INTERNET AUCTION AND TO RATIFY THE PLACEMENT OF ITEMS CURRENTLY LISTED BY INTERNET AUCTION, AND DECLARING AN EMERGENCY.

WHEREAS, personal property, including motor vehicles acquired for the use of municipal officers and departments, and road machinery, equipment, tools, or supplies, becomes obsolete, unfit for the use for which it was acquired, or no longer needed for public use; and

WHEREAS, Council desires to sell said personal property by internet auction to generate more revenue for the City and to make items available to a larger community of potential buyers.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF MONROE, STATE OF OHIO, THAT:

SECTION 1: Council hereby expresses its intent to sell personal property, including motor vehicles acquired for the use of municipal officers and departments, and road machinery, equipment, tools, supplies, confiscated vehicles and property, and items obtained through law enforcement investigations, which is not needed for public use, or is obsolete or unfit for the use for which it was acquired, by internet auction.

SECTION 2: The personal property as referenced in Section 1 shall be sold using the internet auction site <http://www.govdeals.com>. The number of days for bidding on the personal property shall be for ten days, including Saturdays, Sundays, and legal holidays. The City Manager or designee shall have the option to place a minimum bid on any item, establish any other terms and conditions for the particular sale, including requirements for pick-up or delivery and method of payment. Items shall be sold to the highest bidder.

SECTION 3: Council hereby ratifies the placement of items currently listed by internet action.

SECTION 4: This measure is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare and further for the reason that Council desires to proceed with the sale of certain personal property at the earliest possible date. Therefore, this measure shall take effect and be in full force from and after its passage.


